Training of Trainers (ToT) on EVD Preparedness, Surveillance and Response 30 September 2019

In line with the Government of Rwanda's (GoR) National Capacity Building Plan on EVD and IOM's Health, Border, and Mobility Management framework, IOM Rwanda's OSBP project has tailored its IBM approach in Migration and Health to support the GoR in EVD Preparedness, Surveillance and Response.

On the 30th September 2019, IOM Rwanda and the Rwanda Biomedical Center (RBC) jointly organized a Training of Trainers (ToT) on EVD Preparedness, Surveillance and Response, for 48 Community and Environment Health Officers from the Western and Central provinces.

As a result of this ToT, a new pool of community health trainers that were up-skilled during the session

will cascade the training to Rusizi border authorities and communities.

During the training, participants have acquired knowledge in:

- EVD preparedness and surveillance measures;
- How to treat a suspected or confirmed case of EVD;
- How to communicate on EVD outbreaks and possible cases via existing community structures;
- The roles and responsibilities of District Hospitals in EVD response mechanisms;
- The procedures of specific referral of possible identified EVD cases and;
- EVD symptoms, treatment and prevention measures that they will cascade to community members.
